WHEREAS, Mr. Dunlap is now eligible to receive retirement benefits from the School Teachers Retirement System; and

WHEREAS this Board of Education is desirous of retaining the services of Mr. Dunlap as Superintendent;

BE IT THEREFORE RESOLVED by the Board of Education of the Blanchester Local School District that it hereby:

1. Accepts the resignation of Superintendent, Randy Dunlap, submitted for purposes of initiating earned retirement benefits, effective July 31, 2023.
2. Re-employs Randy Dunlap as Superintendent for the term beginning on August 2, 2023, and ending on July 31, 2026, such employment to be in accordance with the terms and conditions set forth in the written contract.

Appendix B

Mr. Wilson introduced the following resolution and moved its passage:

RESOLUTION NO. _____
AUTHORIZING AGREEMENT WITH COMPLETE MECHANICAL SERVICES, LLC FOR THE
LIFT STATION UPGRADE PROJECT

The Superintendent recommends awarding a contract to Complete Mechanical Services, LLC ("Complete Mechanical Services") for the District's Lift Station Upgrade Project ("Project") and requests authority to negotiate and enter into an agreement with Complete Mechanical Services for the Project.

Rationale:

1. The Board identified a need to replace the existing lift station at Blanchester High School as part of a multi-layered approach to mitigate the impact of Covid-19.
2. The Project is outside the scope of the competitive bidding requirements defined in ORC 3313.46. ORC 3313.46 only requires competitive bidding for work related to "school buildings," and the relevant work set forth in the agreement is not to build, repair, enlarge, or demolish a school building.
3. However, the District will pay for the Project using federal grant funding made available to the District through the Elementary and Secondary School Emergency Relief ("ESSER") fund.
4. Accordingly, the District, in compliance with 2 CFR 200.320(a)(2), solicited competitive pricing proposals from three (3) qualified firms to replace the existing lift station system, which the Board finds is an adequate number of qualified vendors.
5. Through this solicitation process, Complete Mechanical Services was determined to be an experienced lift station contractor and the firm in the best interest of the District to perform the Project.
6. Complete Mechanical Services has provided a proposal for the Project in the total amount of \$53,212.00, which the Superintendent, and Treasurer, believe to be appropriately competitive based on current market pricing.
7. The Superintendent recommends approving the selection Complete Mechanical Services for the Project and authorizing the negotiation of an agreement with Complete Mechanical Services for the Project in an amount not-to-exceed \$53,212.00 ("Contract Sum").
8. Additionally, the Superintendent requests authority to enter into change orders on behalf of the Board in a total amount not to exceed 10% of the Contract Sum; change orders in excess of that amount will be brought to the Board for its approval.

The Board of Education resolves as follows:

1. Based upon the information provided, the Board finds that they have received price quotations from an adequate amount of qualified vendors.
2. The Board approves the selection of Complete Mechanical Services as the firm in the best interest of the District for the Project and authorizes the Superintendent, and Treasurer, working with legal counsel, to negotiate and enter into an agreement with Complete Mechanical Services for the Project in an amount not to exceed \$53,212.00, and to execute any other documents consistent with the intent of this resolution.
3. The Board further authorizes the Superintendent and Treasurer to sign change orders related to the Project in a total amount not to exceed 10% of the Contract Sum; should a change order exceed this amount individually or as the aggregate of change orders for the work, the change order will be brought to the Board for approval prior to the work being performed.

Mr. Williams seconded the motion and, after discussion, a roll call vote was taken and the resolution passed.
